SPECIAL FARES FOR CAMP LINCOLN AND CAMP LAKE HUBERT ON NORTHWEST *

Just as Travel One is camp's travel agency of preference, Northwest Airlines is camp's airline of preference.

Northwest Airlines has provided Camp Lincoln and Camp Lake Hubert with discounted camp fares that should be cost competitive with any airfare offered for similar summer travel. These special fares are in the form of an up-front discount which will be applicable to the lowest Northwest Airline fare available at time of booking. See the attached form for suggested flights and restrictions.

*** In addition to the special negotiated camp fares, Northwest Airlines assists with the luggage collection process upon arrival into Minneapolis and provides special assistance with luggage handling and check-in procedures on camp departure days. (Campers bypass normal Northwest check-in procedures)**

FARES ON OTHER AIRLINES

Travel One issues air tickets on all air carriers and will be happy to assist with all travel reservations. New this year to the Mpls/St.Paul market is Southwest Airlines, they offer non-stop service from Chicago/Midway to Mpls. Travel One issues tickets on Southwest Airlines. Campers traveling on carriers other than Northwest Airlines may be able to purchase competitively priced tickets. If you are traveling on an airline other than Northwest, please respond to Travel One promptly or as soon as your travel plans are definite, Travel One will be happy to quote fares. If the fare is competitive to the Northwest fare, camp prefers that you travel on Northwest since they provide assistance at the Mpls/St. Paul airport.

ALL TAXES, AIRPORT FEES AND TRAVEL AGENCY FEE INCLUDED

When Travel One quotes an airfare price, it will be inclusive. Included in the price is a nominal \$22.00 travel agency fee. If you choose to pay for your ticket via credit card, this \$22.00 agency fee may appear as a separate billing item. Both camp and Travel One believe that the quoted fares will be competitive to any other fare available for similar travel. The camp family is also responsible for round-trip unaccompanied minor service fee if applicable and payable at time of departure to camp. Northwest Airlines (all major airlines) charges luggage fees of \$15.00 for the first checked bag and \$25.00 for the second checked bag each way of travel. Parents will need to pay the to camp luggage fees at the airport upon departure; however; the return home luggage will be paid by camp and charged to your campers account.

ENHANCED AIRPORT SECURITY AND UNACCOMPANIED MINOR INFORMATION

The events of September 11, 2001 have dramatically changed airport security. As a camp traveler you must check-in at the airline ticket counter in order to process the unaccompanied minor paper work, and should allow additional time for the airport check-in process. (a minimum of 120 minutes). Travel One is confident that you will be allowed to accompany your camper to the gate upon departure and a camp representative **will definitely** be at the gate in Minneapolis to meet your youngster. The latest information concerning unaccompanied minor travel is enclosed with this mailing. Travel One will mail along with your E-ticket receipt, three weeks prior to departure, additional or updated information.
