#### **SOUTHWEST AIRLINES SERVICES MINNEAPOLIS/ST. PAUL**

Southwest offers nonstop service between Minneapolis/St. Paul Hubert H Humphrey (Terminal #2). Travel One will verify with the camp to make sure there are camp representatives at that terminal. Please note that Southwest only allows unaccompanied minors on direct flights.

#### **TRAVEL AGENCY FEES / LUGGAGE FEES**

When Travel One quotes an airfare, it will include a nominal \$25.00 travel agency fee. If you choose to pay for your ticket via credit card, this \$25.00 agency fee may appear as a separate billing item. All major airlines charge luggage fees. This information is located on the airline's website.

#### **UNACCOMPANIED MINOR INFORMATION**

The camper's family is responsible for the round-trip unaccompanied minor service fee, if applicable. You must check in at the airline ticket counter to process the unaccompanied minor paperwork. Please allow additional time for the airport check-in procedure (a minimum of 2 hours). A camp representative **will be** at the gate in Minneapolis to meet your child. The latest information concerning unaccompanied minor travel will be enclosed with your updated itinerary three weeks prior to departure.
